Motion by Quamme, seconded by Schneider, to approve the 2020 Pool and Fitness Center Rates. The Board will be given a progress report in March regarding the new rates. Motion carried on a voice vote 6-0.

Motion by Quamme, seconded by Setz, to approve the 2019-2020 Short Term Borrowing agreement in the amount of \$500,000 with Farmers and Merchants Bank of Waterloo. Motion carried on a voice vote 6-0.

Motion by Setz, seconded by Schneider, to approve the 2019-2020 Budget and Tax Levy. General Fund \$3,131,587; Debt Service: \$1,203,180; and Community Service Fund: \$270,000 for a total Tax Levy in the amount of \$4,604,767; Mill Rate at a rate of .01035223; Total Budget in the amount of \$10,073,635. Motion carried on a voice vote 6-0.

Motion by Thompson, seconded by Kegler, to enter into Closed Session Pursuant to Wisconsin Statutes 19.85(1) (c), (e) and (f), the Board of Education may move into Closed Session for the purpose of:
